Application and acceptance of the terms :

These Terms of Use govern, without exception, the legal and contractual relationship between the micro-enterprise STARLANCER STUDIOS and users of the website <http://www.minecraft-worlds.com> and its various pages and the benefits proposed by Free Minecraft Hosting on these pages, subject to any contrary provision confirmed in writing by Free Minecraft Hosting. The use of Web pages or services <http://www.minecraft-worlds.com> is general acceptance by the users of these terms of use.
